Please note this is an application for Permanent Court Time (PCT) and is subject to change or deletion if required by the Dodds Tennis Center.

1. Application must be completed in order to purchase new, change or renew PCT. **All participants must be members of the Champaign Park District Dodds Tennis Center and have renewed their membership or purchased one prior to the start of the session. Applications are due December 28, 2020.** Please return application form to the Dodds Tennis Center, 2802 Farber Drive, Champaign, IL 61822 or email to stacey.cornell@champaignparks.org.
2. The captain must retain a copy of this application as proof that the court time was applied for. Spring PCT begins January 12, 2021 and continues through May 17, 2021 (18 weeks). There will be no meetings on April 4 (Easter). Groups scheduled to meet on this day will have their fees prorated. **Changes made after the session has begun must be handled by the players. No refunds will be issued.**
3. No rainchecks will be offered or honored for missing any PCT during the session, unless PCT is cancelled by the Dodds Tennis Center due to poor weather, facility or staff issues.
4. Participants will be billed for PCT fees (membership not included) after March 1, 2021, and all fees must be paid in full prior to April 30, 2021. Fees may be divided among the group in any fashion. Failure to submit a roster prior to the start of the session may result in forfeiture of court time. Substitutes are not required to pay PCT fees.
5. Your PCT group may include the cost of tennis balls for the session with their PCT fees. The cost is \$3.75 per can, one can per court, per day.
